

Dear friends,

Against the background of the current sanitary crisis, the ERA Team has carefully selected some materials/resources which could be of immediate relevance for your trainers and/or your judges and prosecutors. They are ordered below by legal topics:

### **(a) Judicial cooperation in civil matters**

On the **EU Civil Justice instruments** you will find training packages consisting of [multilingual case studies](#) (incl. case scenario, suggested solution, and some methodological advice for using the cases) and a [library](#). These resources, which were developed in 2015, cover the following topics: “Cross-border civil litigation”, “European cross-border procedures” and “Conflict of laws”.

Similarly in the area of **Family and Succession law**, comprehensive case studies were drafted in 2017 on “Cross-border divorce and maintenance (Brussels IIa and Maintenance Regulation)”, “Parental responsibility in a cross-border context, including child abduction (Brussels IIa)” and “Cross-border succession”. These case studies are available [here](#) and are also complemented by a [library](#) in 12 languages.

On **cross-border mediation** - both family mediation and civil/commercial mediation - several [materials](#) were developed in 2018 and remain at your disposal: case studies, linguistic manuals, speakers’ presentations, background documentation.

Although they would need to be partly updated by your trainers in case they wish to make use of them, the multilingual training modules on [the European legislative instruments for cross-border cooperation in civil matters](#) - which were conceived in 2014 - can still be of benefit.

Last, but not least, a basic interactive [online tool on Legal English for Judicial Cooperation in Civil Matters](#) of 2016 can be used.

### **(b) Judicial cooperation in criminal matters**

### **(c) Competition law and State aid law**

In the area of anti-trust law, various resources have been developed specifically for judges/prosecutors as well as trainers.

**Basic yet comprehensive materials on Articles 101 and 102 TFEU, the Damages Directive** and its transposition into the domestic legal systems of the Member States, and on **EU State aid rules** can be found [here](#) in the form of multilingual PowerPoint presentations and background documentation as well as video-podcasts in English, French and German.

Further e-presentations produced in 2018 in English and German can be found regarding **antitrust enforcement in digital markets in the framework of Art 101 and 102 TFEU and merger control**.

In addition, you will find [e-presentations](#) delivered by economists and academics aiming at providing national judges with a good understanding of **basic economic concepts in EU competition law** and with the tools to assess economic evidence and to quantify the harm caused by infringement of competition rules.
